# General terms

### 1 Amendments to the Constitution

#### 1.1 Amendment

The Manager declares that by this supplemental deed, the Constitution is modified by amending clause 3.14 as follows:

- (a) delete "only" in the first line;
- (b) delete "or" at the end of (c);
- (c) insert "or" at the end of (d);
- (d) insert (e) as follows:
  - (e) it is not in the interest of the Trust to do so.

### 2 No redeclaration etc

The Manager declares that it is not, by this deed:

- (a) redeclaring the Scheme or declaring any trust;
- (b) resettling the Scheme; or
- (c) causing the transfer, vesting or accruing of property in any person.

#### 3 Effective Time

The amendments made by this supplemental deed take effect from the date a copy is lodged with ASIC pursuant to section 601GC(2) of the Corporations Act.

## 4 Governing law

This deed is governed by the laws in force in the place specified in the Details. Each person affected by it must submit to the non-exclusive jurisdiction of the courts of that place and the courts of appeal from them.
