#### 1 Amendments to the Constitution

#### 1.1 Amendment

The Manager declares that by this supplemental deed, the Constitution is modified by amending:

- (a) clause 27.2 by inserting the words "Class A" before the words "Income Units" each time they appear in the clause;
- (b) clause 28.1 by replacing the definition of "Prescribed Percentage" with the words "in respect of Class A Income Units means 10% of all Units on issue, or such other percentage as the Manager may determine from time to time.";

#### 2 No redeclaration etc

The Manager declares that it is not, by this deed:

- (a) redeclaring the Scheme or declaring any trust;
- (b) resettling the Scheme; or
- (c) causing the transfer, vesting or accruing of property in any person.

#### 3 Effective Time

The amendments made by this supplemental deed take effect from the date a copy is lodged with ASIC pursuant to section 601GC(2) of the Corporations Act.

#### 4 Governing law
