# General terms

### 1 Amendments to the Constitution

The Manager declares that by this supplemental deed, the Constitution is modified by:

(a) replacing clause 3.6 ("No fractions of Units") with the following new clause:

#### "3.6 Fractions of Units

Fractions of a Unit (calculated to 2 decimal places, or such greater number of decimal places as the Manager may from time to time determine) may be issued by the Manager but, while the Units are Officially Quoted, fractions of a Unit may not be issued.";

(b) replacing clause 3.7 ("Rounding of fractions") with the following new clause:

#### "3.7 Treatment of fractions

The provisions of this constitution relating to Units and Members apply to fractions of Units in the proportion which the fraction bears to one Unit."; and

(c) deleting clause 9.16 ("Money held for future reinvestment").

# 2 No redeclaration etc

The Manager declares that it is not, by this deed:

- (b) resettling the Scheme; or
- (c) causing the transfer, vesting or accruing of property in any person.
