Multiplex Acumen Property Fund is a listed property trust that predominately invests into unlisted property securities. MPF provides investors with exposure to returns from direct property and tax-advantaged distributions with the liquidity benefits of an ASX listing. MPF is strongly diversified across three asset classes, five property sectors, 11 geographic locations and 31 managers. MPF's assets are spread over a portfolio of 59 different property investments which provide indirect exposure to almost 3,000 properties that reflect an average lease term to expiry of circa 6.2 years.
